Lafayette when he visited the United States the last time."

In the "Summer Issue, 1958", we gave the line of Philip Dufford and Clarissa Dickerson, including the line of Andrew B. Henry and Elizabeth D. Dufford. Now Miss Belle Dufford gives us another branch of that line, that of Henry Clay Dufford, as follows: "Henry Clay Dufford, (June 26, 1833 - Nov. 6, 1920) was married Dec. 24, 1854 to Isabelle Bridel (July 5, 1833 - March 23, 1907) daughter of Robert and Mary Diamond-Bridel, and to them were born: -
