#### THE 1966 REUNION

Splace will not permit a full account of the business transacted but your attention is called to the list of newly-elected officers above.

The following is an excerpt from the minutes as written by our new Secretary, Mr. William O. Hart:

"The nineteenth annual meeting of the Swackhamer-Dufford Genealogical Society was held on July 25, 1966 at the Zion Lutheran Church in Long Valley, N.J. with more than sixty persons present. Sixty-one persons registered but apparently a number missed doing so. This was the twenty-sixth meeting of the Swackhamer family and the forty-first meeting of the Dufford family.

Members began arriving at the church in mid-morning. Several from distant points had been in the area since the day before. At noon a pleasant picnic hour took place. Mr. and Mrs. Wesley J. Moren of Scotch Plains, N.J. provided and served coffee.

At the conclusion of the picnic luncheon, Dr. T. Cecil Swackhamer, president, of Stamford, Conn., called the meeting to order, extended his greeting and reminded the meeting that the families had lived in this area for 236 years. Following this each person stood in turn and introduced himself, gave his home town and his connection with the families. These introductions revealed that members had come from many distant points: Oklahoma, Illinois, Connecticut, Virginia and upstate New York. Still it is evident that the families continue to have solid representation from the area within twenty-five miles of the point of original settlement. Ages ranged from two to the eighties. The sixth through ninth generations were represented. The number of children present would indicate that the lines were not ready to die out. Several persons present had the blood of both lines.

During the course of the day there had been many informal discussions of genealogy and of the past year's births, deaths and marriages in the families. Of great interest to everyone was the genealogical information assembled by Miss D. Francis Paine of 365 Morningside Ave., Bartlesville, Oklahoma.

Dr. Swackhamer called us to solemn remembrance of the departed members of the families and invoked the Divine blessings for all of us. It was moved and passed that the meeting adjourn. Although formally concluded it was observed that many family members were reluctant to take their departure.

#### CARTOGRAPHERS TAKE NOTE

Mr. Robert O. Hart, an instructor in social studies at Asbury Park High School, has the original copy of a bill introduced in 1852 which would have created the County of Musconetcong from portions of Hunterdon, Warren and Morris. The Senate journal indicated the bill was laid over to the 1853 session and then tabled and still may have been awaiting action had not the 1947 State Constitution declared a bill not acted upon by adjournment dies with the outgoing session.

SENATE BILL NO. 43 STATE OF NEW JERSEY - introduced February 15,1852

An Act to erect parts of the counties of Hunterdon, Warren and Morris into a new county to be called the County of Musconetcong.

Boundaries - Beginning at the southwesterly corner of the township at Lebanon, in the county of Hunterdon, in the middle of the Musconetcong Creek, and running thence along the southern and eastern boundary of said township of Lebanon to the boundary line between the counties of Hunterdon and Morris, where it crosses the south branch of the Raritan River, thence northwardly up said south branch to a point where the east line of Daniel Delts farm crosses the same, thence in a line to the most westerly corner of the Presbyterian Parochial School House at German Valley, thence in a straight line to the most easterly corner of the school house near Bartleyville, thence in a straight line to the most southerly part of Hopatcong Lake, thence along the shore of said lake to the middle of the Musconetcong Creek at the outlet of said lake being the line between the counties of Morris and Sussex, thence down the middle of said Musconetcong Creek the several courses threof to the corner of Sussex and Warren counties, thence along the boundary line between the counties of Sussex and Warren to the middle of the Paulenskill Creek, thence down the middle of the creek the several courses thereof to the most westerly corner of Frelinghuysen township in the said county of Warren, thence along the boundary line of said Frelinghuysen township and the townships of Hope and Independence to the corner of Mansfield township in the middle of the Pequest Creek, thence along the westerly and southerly boundary of said township of Mansfield to the line of the township of Washington, thence along the line between the townships of Mansfield and Washington to the corner of said townships in the middle of the Musconetcong Creek and thence down the middle of said creek the several courses thereof to the place of beginning, be, and the same is hereby erected into a separate county of Musconetcong, and said lines shall hereafter be the division lines between the counties of Hunterdon, Warren, Sussex and Morris, and the county of Musconetcong respectively, including and intending to include within said metes and bounds all the townships of Lebanon in the county of Hunterdon, and all the townships of Mansfield, Independence and Frelinghuysen and the town of Hackettstown in the county of Warren, and so much of the townships of Roxbury and Washington in the county of Morris as is embraced within the boundary lines herein before described.

#### LONG VALLEY TO HAVE MUSEUM AND LIBRARY.

The Hopler House, the first schoolhouse in Long Valley, may soon become the Washington Township station of the Morris County Free Public Library.

The historical society and the Long Valley Woman's Club have joined forces in a new corporation, the Washington Township Library Association, Inc. The plan is to buy the two-story stone building built in 1830. The ground floor will be used as the library allowing space for more than 3,000 county library volumes, compared to the 800 now kept in the township library at the Long Valley School. The second floor will be headquarters, museum and public meeting rooms for the Washington Township Historical Society. The historical society's collection would be on display in the building instead of being kept in members' homes.

The old building stands beside ruins of the old Evangelic Reformed and Lutheran meeting house, built in 1774. The historical society owns the church property, including the cemetery with tombstones dating back to 1766.

#### MIDDLE VALLEY P.O. FIGHT

Mr. Frank W. Dufford is leading a fight to save the Middle Valley Post Office.

For economic reasons the Post Office Department proposed consolidation of the Middle Valley post office with the one in Long Valley. The 74 families who live in this community are protesting this move. They ask that the tiny post office which possibly dates back to 1802 be retained. Admittedly, pride is involved. If the post offices close, Middle Valley will be just one more hamlet in sprawling Washington Township, without the identity its residents cherish. So long as it has a post office, Middle Valley is a place with a name - an address to which people can relate.

#### ANOTHER FAMILY MEMBER IN THE NEWS

As architectual adviser engaged by the Somerset County freeholders, James Swackhamer advised the courthouse be torn down rather than modernized. He said razing the 60 year old structure would be wisest and more economical.

This is the fourth county courthouse in the 250 year history of Somerset County. The second courthouse, located then in the Millstone area, was burned to the ground by the British in 1779. The present building was the scene of the Hall-Mills murder trial in 1926.

News from Westport, Conn.--Among the ten Staples High School seniors to be named semi-finalists in the 1966-67 Merit Scholarship Competition is Donald Harriman. Quoting John M. WAS THE "D" ADDED TO OR DROPPED? An interest in the name of Ufford and its connection, if any, with the Dufford or Tufford family prompted your editor to investigate the matter.

Contact was made with Mrs. Frank S. Ufford of Vermillon, S. D. She graciously responded with the following: "Since your letter came, I have looked in vain for a newspaper (N. Y. Star, I think) clipping that suggested the "D" was dropped from Dufford. To the best of my knowledge there is no connection in this country. The Ufford family originated in Newbourne Co., Suffolk, England (See "Planters of the Common wealth" by Banks, pages 99-100). These facts are well corroborated: Thomas Ufford, wife. Isabel, sons Thomas and John, daughter Abigail who married Roger Terrill were in Roxbury in 1632, having sailed in The Lion June 22 and arrived in Boston September 16. In the William Pyncheon settlement at Springfield, Mass. 1638, the name was variously spelled Uffet, Uffert, Uffett, Uskett, Uffoote, Uffort, but THANK YOU, MRS. UFFORD. no "D" prefix.

#### Tax Lists consulted

Annette Wert Hart and her husband did some research in the Genealogical Section of the State Archives (Trenton, N.J.). Annette wrote "This sort of thing is new to us so we were a bit long getting started. We are going to have to go back some day with a magnifying glass and a strong portable light and, of course, get started earlier in the day." From the microfilm copies of the Morris County tax lists, Western Precinct (Washington Twp.) for 1783, the year the REvolutionary War ended they found the following:

Jacob Dufford 3rd	no land but 2 horses & 4 cows	.24

### DESCENT OF FRED SISSER, III FROM SAMUEL SCHWACHHEIMER

- 1. SAMUEL SWACHHEIMER, (as he signed his name in his last will and testament 1), was described as "a good Pallantine" 2, and was probably born in about 1699-1700. 3 He came to the New World in 1731, and ultimately settled in the "wilderness" of Hunterdon County, New Jersey. 3 Samuel accordingly married three times and had twenty-five children altogether. 3 Samuel resided "in the Valley", known as Germany Valley, and later as Long Valley. He died, "in the Valley" on February 3, 1782, and was buried in the "churchyard at Zion's Church". 3
- 2. CONRAD SWACHHAMMER, the eldest son of Samuel Swachheimer, was born about 1720, probably in the Palantine, Germany. He resided near New Germantown, Hunterdon County, and married ELISABETH -----, (surname unknown), and they had seven known children. Elisabeth was born about 1721, and was buried at "the Valley Church", on August 12, 1794. Conrad Swachhammer died in August 1813, in his 93rd year. 4
- 3. CONRAD SWACKHAMER, the son of Conrad and Elisabeth Swachhammer, was born November 30, 1753, in Hunterdon County, New Jersey. "Conrad Schwachheimer Jun" and MARIA RULOFSON were married in the Zion Church on May 15, 1774. Maria was the daughter of Hermanus and Margaretta (Van Hoorn) Rulofson, and was born February 10, 1751, in Readington Township, Hunterdon County, and died August 27, 1816, in Hunterdon County. Conrad Swackhamer died September 19, 1831, in the same county.
- 4. ROELOF SWACKHAMER, the son of Conrad and Maria (Rulofson) Swackhamer, was born September 8, 1787, in Hunterdon County, New Jersey.<sup>8</sup> He died in Readington Township, Hunterdon County, on April 20, 1846.<sup>9</sup> Roelof married October 10, 1812, Mary Schamp, <sup>10</sup>, the daughter of Pieter and Margrietje (Huffman) Schamp. She was born December 31, 1790, in Readington Township, and died in the same Township on July 23, 1859.<sup>9</sup>.
- 5. ANN WYCKOFF SWACKHAMER, the daughter of Roelof and Mary (Schamp) Swackhamer, was born December 7, 1827, in Readington Township, Hunterdon County, 11, and died August 7, 1855 in Hunterdon County, age 28.12 Ann married, September 27, 1848, JOHN ROCKEFELLER EMERY, the son of Peter and Ann (Rockefeller) Emery. He was born July 22, 1827, at Dreahook, Hunterdon County, and died June 17, 1880, at Bloomington (South Bound Brook), New Jersey. 12
- 6. ANNIE MARY EMERY, (1850-1926) married, October 15, 1873, CORNELIUS STEWART HOFFMAN (1852-1936).
- 7. CARLTON EMERY HOFFMAN (1885-1945) married September 29, 1915 MARY VIRGINIA MILLER, (1892 - ).
- 8. VIRGINIA MARY HOFFMAN, (1918 )., married October 29, 1938, FRED SISSER, JR. (1916 ).
- 9. FRED SISSER, III, (1940 ).
