The Petition of John Hager, Philip Schuiler, Anthony Waldorf, John Boon, George Revell, Martin Shrive, Samuel Schwackhamer — Humbly herewith —

That whereas your honors, petitioners were born in the Empire of Germany and of the allegiance of the present Majesty George the Second King of Great Britain and whereby they are deprived of the privileges and benefits of natural born subjects of this said majesty, yet - conceived from their long residence in this Providence they may receive the benefits arising from foreigners by virtue of an act of Parliament made in the thirteenth year of his present majesty's reign, instituted an act for naturalization such foreign Protestants and others therein mentioned as are settled or shall settle in any 06 his Majesty's colonies in American. Your Petitioners therefore humbly pray your honors would be pleased to take their condition in consideration and admit them to the benefit of the said act. And your petitioners as in duty bound shall ever pray -

The honorable Samuel Nevill, Esq.

John Hager, Philip Schuyler, Anthony Waldorf, George Revill, Martin Shive and Samuel Schwackhiemer, foreign Protestants, having produced certificates duly attested of their having received the sacrament of the Lord's Supper from a Protestant minister of the Gospel pursuant to [an] act of Parliament and prayed to be admitted to the benefit of the said act. And having proved their residence in this province for more than seven years without being absent out of the colonies for two months at any one time. They took the oaths and made and subscribed the declarations as appointed in and by said act.

received the sacrament of the Lord's Supper from a Protestant minister of the Gospel - pursuant to the Act of Parliament for naturalizing foreign Protestants prayed to be admitted to the benefit of the said Act. Acting upon a lead from Diane Ptak, as reported in the Summer 1991 issue of the Schwachamer-Duford Genealogical Society Bulletin, my wife, Lillian, and I visited the village of Altlussheim and there found the Germany link to our immigrant ancestor Samuel Swackhamer!

Altlussheim (Spelled Altlußheim in German if you are looking for it on a German map) is a delightful farming community on the East Bank of the Rhine River. Tobacco, sugar beet and strawberry fields dot the landscape. It is just across the Rhine from Speyer, and about 20 miles Southwest of Heidelberg. Altlussheim had a population of 5006 in 1987. In Roman times there was an important river crossing here. Back in 1731 and earlier when Samuel and his ancestors lived there the population was only about 400. The name of the municipality was Lussheim. In January, 1821, the municipality was divided into Alt(old)lussheim and Neu(new)lussheim. Lussheim was located in what has been called the Rineland Palatinate, the Bavarian (Rhenish) Palatinate, Pfalz, and Baden. It is now in the State of Baden-Wurttemberg

The municipality of Altlussheim has two churches, Evangelical (Protestant) and Catholic. The "Evangelischer Kirche" is Lutheran. You will find Schwechheimers quite in evidence. There are about a dozen in the telephone directory, there is a Schwechheimer Shoe Store, a Karl-Heinz Schwechheimer is (or was) the municipal penal officer, and there is even a pew in the Evangelical Church with "Schwechheimer" carved at the center aisle end.

Speyer (or Spires) has a population of about 44,000. It "was one of the great cities of the Holy Roman Empire". The cathedral in Speyer, the Kaiserdom, is "one of the largest medieval churches in Europe," and "certainly the finest Romanesque cathedral in Europe." It took only 30 years to build, between 1030 and 1060. "Of the numerous imperial diets held here, the most important was that of 1529, under Charles V., after which the princes and estates who had expoused the cause of the Reformation received the name of *Protestants*, from their protest against the resolution of the hostile majority." Speyer was

destroyed by the French in 1689 during the invasion of 1687-1697. In 1892, K. Baedeker writes that Speyer "has only recently begun to prosper again." Today, Speyer is a thriving city with the cathedral restored.

We were graciously received in the parsonage of the Rev. Eugen Fuchs and his lovely wife, Gertrud. There, we were presented with the documented genealogy of the Schwechheimers in Altlussheim prepared by Ewald Ballreich, one of the Churches parishioners! Genealogy is a hobby of Mr. Ballreich. What follows is a brief summary of what he found.

Samuel Friedrich Schwechheimer, born 2 Jan 1701, son of Daniel Schwechheimer and Apollonia (unknown), married 18 Feb 1721 to Eva Maria Hoffmann, daughter of Joh. Hoffmann of Hockenheim. Their first child was Johann Konrad, born 27 Feb 1723 (our ancestor). They had three other children who either died in childbirth or within a short time after their birth.

Eva Maria died 1 Jul 1728. Samuel's second marriage was on 25 Jun 1729 to Anna Katharine Kuch, daughter of Bernhard Kuch of Zuzenhausen. They had one child, born in Jan 1731 and died in Apr 1731. There is no further record of the Samuel Friedrich Schwechheimer family in the church records, since he came to America in 1731.

Daniel Schwechheimer, born 15 Jul 1657, died 21 Nov 1719, son of Christopher Schwechheimer and Barbara Theobald, married 29 Sep 1685 to Apollonia (unknown). Daniel had two other wives and a total of 13 children.

Christopher Schwechheimer, born 19 Sep 1624, died after 1657, son of Amandus Schwechheimer and Katharina (Unknown), married 27 Jun 1653 to Barbara Theobald, daughter of Andreas Theobald. They had a daughter, Maria Barbara, in addition to Daniel.

Amandus Schwechheimer, baptized 17 Dec 1597, died 19 Aug 1635 in Speyer, son of Johannes Schwechheimer and Margaretha Mudel, married Katharina (Unknown). Then had four children recorded.

Johannes Schwechheimer, died 3 Mar 1614, son of Jakob Schwechheimer, married in 1588 to Margaretha Mudel, died 15 Mar 1611, daughter of Marcus Mudel of Lussheim. They had nine children. Amandus had three older sisters and four younger brothers. Their last was Apollonia, born in 1607 and died the same day as her mother. Johannes married Margaretha Obermuller, daughter of Johann Obermuller of Asbach, near Schwabisch Hall, and widow of Adam Nold. She died 10 Aug 1612.

The only record of Jakob Schwechheimer is that he had a son named Johannes, was a citizen of Lussheim, and died before 1588.



There is a lot more to tell. I am in the process of writing an article for publication later this year, or early next that will cover all I know of Samuel and his ancestors in Germany as well as his life in America. In addition, Nancy Schanes of Delaware has researched the trials and tribulations of the voyage and its aftermath of the ship Love and Unity that landed on Martha's Vineyard in 1731. It's a fascinating story and should be published next year.

This finally ends all the speculation of Samuel Swackhamer's origin in Germany. Previously it was thought that he came from Neuwied, further north on the Rhine, just above Koblenz. Many Palatinates left Neuwied and other Palatinate communities in the 1709-1710 period. The next large emigration didn't occur until the ninetieth century, so Samuel's emigration in 1731 was not part of any major exodus. Another community mentioned as a possibility for the origin of the Swackhamer name was Schwaikheim, located about 10 miles NE of Stuttgart. There is still the possibility that the name originated there.
